


WINTERSCHOOL IN ROVANIEMI (LAPLAND, FINLAND), JANUARY 2020

This intensive study program took place from the 19th to the 26th of January 2020 in Rovaniemi, the capital of Lapland, the northern most region in Finland. Course "Multilevel Governance of Natural Resources in the Arctic"

The different themes of the course *Multilevel Governance of Natural Resources in the Arctic* were explored through numerous challenging presentations:

Course "Arctic Indigenous Peoples Law"

The themes of the course *Arctic Indigenous Peoples Law* were dealt with through several conferences/debates:

- Professor Gudmundur Alfredsson, Universityof Akureyri (Island): "Greenlandic Self-determination"
- » Senior researcher Tanja Joona, Arctic Center, University of Lapland: "Indigenous peoples' rights to land in the Arctic with Comparative approach, including Finland, Sweden and Norway - Legal cases from Sweden and a different model (Finnmark Act) in Norway"
- » Professor Soili Nysten-Haarala, ResearcherMaria Tysiachniouk et Postdoctoral Researcher Minna Pappila (University of Turku): "Indigenous and minorities' Rights in Russia. Russian Legislation (federal and regional level) and practice based on empirical findings"

A visit to Reindeer herding cooperative of Palojärvi (60km from Rovaniemi) where students are introduced to the everyday life of reindeer herding, before attending a presentation by Senior researcher Juha Joona "Reindeer herding right in Finland and Sweden - administration and the right to use land"
